



OpenVPMS Screen shots for comment – especially related to updated USER INTERFACE








Invoice Screen



- Max column width to protect the horizontal screen real estate.
- Don't wrap text to the next line; - create a 'hover over' to show the full text.

These two problems often mean that you need to jump up and down on the screen to see the whole invoice; particularly on smaller computer screens.

Specific table column(s) to be editable; eg quantity.
Option with check boxes to select and delete more than one line at a time.

Scroll the table rather than page across (pg 1 of 2)

When applying a template to an estimate or invoice, we have a check box to chose which of the items are able to be added. This can be controlled from the product template (column added for 'allow user to preselect to not add to invoice). Product items with investigations / forms (eg microchip) are added and then needed to be deleted creating extra steps



Patient Alerts

These need to be editable when being viewed. EDIT button alongside the CLOSE button

Increase heading font sizes:




We use a tweaked version (by customising <TOMCAT-HOME>\webapps\openvpms\WEB-INF\classes\style\default.properties and ...\default.stylesheet) which looks as follows:



Ignoring the colour difference and our use of practice location banners, I would hope you agree that our size headings are more readable. Suggestion: increase the heading font size that is used in the standard release.

Copy / clone functionality for all the Administration sections.

Would save a lot of time and potentially reduce the risk of entry errors when having to enter the same information in multiple times. Lots of locations where this would be really useful; - especially when setting up a new instance of OpenVPMS or location.



•RIGHT mouse click functionality

• Eg: - Option for each of the function buttons at the bottom of the screen (eg: EDIT / Consult / Check-in / etc)

•ORDERS:

•If you order an item that is already on back order, then we should be prompted to ask if the user would like additional items to go on back order.

•Invoice / Accounts:

Reverse and Copy an invoice;

•When an invoice is added and then at check-out we become aware that the invoice requires a wholesale change (eg: Apply a discount, or the invoice has been completed in the wrong practice location) then we can reverse and copy the invoice (leaving an audit trail). Currently we need to reverse the invoice and the reenter the whole invoice again as separate items / templates.

Warning message if deleting an invoice

• There is a pop up box currently but it appears very very similar to the warning about deleting a single item rather than a whole invoice. This pop up box needs to be a different color / message / etc to make it clearer.

Improvements to SMS functionality

•Abilty to send different SMS messages to different schedules at different times. EG: A boarding schedule may want SMS to be sent a month and then 2 weeks before hand whilst consult schedule may just want it 24hrs prior

Improvements to roles and authorities

•Allow more granular control of activities. Especially for those that may need only some administrator rights.

Patient Check-in system

•Currently we go through 3 pages (chose a worklist / add a weight / add any forms) can this be simplified to one pop up / dialogue box??

More comments

Products

- Ability to be able to have 'dispensing' notes visible for items that are not medications. Eg: Service; - can then have some more detail about a particular item or its list of fixed price option to chose from.
- Product Price History report; this will fit in to with an audit trail (see below).

Schedules

- If you search for a patient and client it will bring you to the client page. You can not add a new consult for that client (and patient) unless you also go into the patient page, after doing the search and before you add the consultation / visit. Tee software will default to the last patient not the last client for adding a new visit. Better to default to the last client and then allow you to chose the patient.
- Drag and drop functionality.

WorkLists

 Ability to be able to chose from a particular worklist which other worklist a transfer can be sent to. For larger groups where there a many many worklists this creates a very long list. We have this functionality in schedules but not worklists.

CRTL-7

a feature for CTRL-Z throughout OpenVPMS. Ie if you accidentally delete an appointment or an invoice or a customer. Even though there are pop-ups to alert you that you are about to delete, would it be possible to CTRL-Z anyway. Would also be really useful if you accidently click 'cancel' instead of 'ok' after finishing a long patient summary note.

Long term??

- 3rd party software integration ability?? without the need to create a new API for each additional feature?? (Not sure it this is related?? https://openvpms.org/project/plugin-support)
- Ability to have more compatibility with other devices;
 - eg: Tablets screen space and document editing on a tablet. Not sure how this can / could work with the current java platform for the editing of documents within OpenVPMS??
